Notices and advance payment must reach the Queen's Printer no later than **1:30 pm** on the deadline date ([see schedule](#)).

Customers requiring **galley proofs** prior to printing must submit copy by 1:30 pm on the Friday before the next publication ([see schedule](#)).

Insertion order requests must be paid in advance. Accepted payment methods include:

- **Visa, Mastercard or American Express** (debit-visa is not accepted at this time).
- **Certified Cheque or Money Order** (no personal cheques) made payable to the Minister of Finance.

Once an order has been received by the Queen's Printer, a secure online payment link will be sent via email.

- **We cannot accept** credit card information by fax or email.
- **Please do not** include credit card information on the insertion order request form, as it cannot be accepted.

Insertion order request forms must be complete in full and all information including signatures must be legible.

- **It is the responsibility** of the customer to verify the accuracy of the submission.
