Notices and advance payment must reach the Queen's Printer no later than **1:30 pm** on the deadline date (see schedule).

Customers requiring **galley proofs** prior to printing must submit copy by 1:30 pm on the Friday before the next publication (see schedule).

Insertion order requests must be paid in advance. Accepted payment methods include:

- **Visa, Mastercard** or American Express (debit-visa is not accepted at this time).
- **Certified Cheque** or Money Order (no personal cheques) made payable to the Minister of Finance.
